Membership Types for REALTOR® members of LUTAR

- 1. Primary** - LUTAR is your Primary local Association; State and National REALTOR® dues will be billed to you through LUTAR along with your LUTAR membership. This class of membership is required if you do not already belong to another local Board/Association.
- 2. Secondary** - Brokers from other local REALTOR® Associations applying to have Secondary Membership are required to submit a Letter of Good Standing from their Primary Association along with payment. All licensees licensed under the broker will be assessed the same rate. Brokers must maintain Secondary Membership for their agents to be secondary members.
- 3. Gateway** - Brokers from other local REALTOR® Associations applying to have Only Realcomp access are required to submit a Letter of Good Standing from their Primary Association along with payment. All licensees licensed under the broker will be assessed the same rate. Brokers must maintain Gateway Membership for agents to be Gateway members.
